# Terms & Conditions for Resident Students

1. The request for accommodation should be compulsorily made through Parents & Guardians.
2. The residential facilities will be available for a term of at least 12 month.
3. Student have to pay per month hostel accommodation charges which will include one meal (dinner) only. Transportation charges are to be paid separately
4. An advance rent of 12 months will be payable at the start of session. Payment in advance on 12 month basis will be compulsory. No reduction is made for any vacation / holidays
5. College will charge a refundable security deposit from the student which will be refund after safe vacation of hostel accommodation and deduction of unpaid dues, bills etc.
6. Transportation charges between hostel and college will be separately (see transport). Hostels situated within campus will have no transportation charges.
7. The residential facilities are provided with food, which will be served at fixed times.
8. Electric appliances like room heater, immersion rods are not allowed in rooms except normal radio, tape recorder and electric iron. Students will pay extra amount if they desire to install Air Conditioner/ refrigerator etc. This amount will be fixed by the administration.
9. Any radio, cassette or CD player must be played without disturbing fellow students. If a complaint is made by students / staff of hostel, the item will be confiscated.
10. The students are required to use the facilities peacefully and without creating any disturbance to the fellow students and the Management.
11. Narcotics of any nature and cigarette smoking are strictly prohibited.
12. No visitors are allowed at any time or on any pretext. The details of y legitimate family relative / visitors will be recorded at the time of registration, for weekly visiting, at designated time. Change in any registered weekly visitor will be furnished to the management in advance.
13. Terms & conditions are valid for one year only and charge may be revised / increased according to inflation, which could not be in normal circumstances, 15% annually.
14. The students will abide the entire instruction / request (as supplied to them) and made by the hostel incharge from time to time.

All the above terms and conditions have been read by my daughter / son ward and me and we agree to abide by them.
